The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:

The school will provide additional suitable facilities for classes XI and XII, as per 1. requirements laid down in the rules.

It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the 2. requirements of the Board for Classes XI & XII.

It will appoint only qualified staff to teach Classes XI & XII as per requirements laid 3.

It will provide facilities for adequate co-curricular and extra-curricular activities for the wholesome development of the students.

It will abide itself by the Athliation bye Laws of the Board and other rules and 5.

regulations prescribed by the Board from time to time.

The school will enroll students proportionate to the facilities available in the school as prescribed in the Affiliation Bye-Laws of the Board which shall not in general exceed the 6. optimum number as under from Pre-Primary to Class XII:-

  - the school has been granted affiliation upto Secondary level w.e.f. 01.04.2609 accordingly it 11. has become eligible to open CBSE pattern classes XI from the session 2009-10 and 1° Batch of class XII of the school will be appearing at the CBSE Examination to be held in the year

  - Special conditions to be complied within three months:-13.
    - A documentary proof regarding implementation and regular deduction of EPF is required to be 1. submitted along with latest Pay Bill and Bank Challan.
    - The school is required to set up Mathematics Laboratory. 2.
    - Shortage of teachers has been observed. Therefore sufficient number of trained and qualified teachers may be appointed to maintain section teacher ratio of 1:1.5 per section as per 3. Affiliation Bye-laws of the Board.
